Councillor R M Jones reported that in the absence of Councillor E Lewis he would defer reporting on the 'Welsh Place Names' topic. Following flooding at a housing estate in the town the programme is set to be completed by next Summer. The planning application submitted to erect a fence at Bryn Aethwy has been 'called in' to committee. A consultation report will go before the executive committee next month regarding school modernisation in the Llangefni area.
