The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

## Auditor General's report

### Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis for Qualification

#### Accounting Statement

I am unable to conclude whether or not the Accounting Statement has been prepared in accordance with proper practice and whether it properly presents the Council's receipts and payments and financial position for the year:

- The Council has not provided the information required for me to complete my audit regarding its fixed assets as the Council does not maintain adequate accounting records for assets owned by the Council. The Council has reported a nil balance for its fixed assets which we deem inconsistent with our understanding of the Council.

#### Arrangements to secure economy, efficiency and effectiveness in its use of resources

In my opinion, the Council does not have proper arrangements in place to secure value for money:

- The Council has failed to comply with its own Financial Regulations in relation to the letting of contracts in the year.

#### Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

#### Approval of settings fees and charges

The Council does not review all fees and charges it sets annually. The Council should formally confirm on an annual basis all fees and charges set by the Council.
