### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £0 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Menai Bridge Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### **Audit opinion: Qualified**

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### **Basis of Qualification**

#### **Accounting Statement**

In my opinion, the Accounting Statement does not properly/fairly present the Council's receipts and payments/income and expenditure and financial position:

- The Council has reported (line 12) that it does not hold any long term assets. This is inconsistent with my understanding of the Council.

#### **Annual Governance Statement**

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 8: The Council has not addressed the recommendations in my audit opinion on the 2020-21 accounts regarding the incorrect reporting of Nil assets.

#### **Arrangements to secure economy, efficiency and effectiveness in use of resources**

In my opinion, the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources:

- The Council's internal auditor has reported that the Council does not maintain an asset register. Therefore the Council is unable to provide assurance that it has safeguarded the assets in its ownership.

## Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

### Matters arising at audit

The Council has not addressed recommendations made in previous internal and external audits. This will be a matter of particular focus as part of the 2023-24 audit.

We recommend that the Council reviews the recommendations made in the 2020-21 and 2021-22 internal and external audit reports and ensures that it addresses the issues raised in these reports.

There are no further matters I wish to draw to the Council's attention.
