Planning Consultation (sent to members electronically)

FPL/2023/264 – Full application for the erection of a two storey building comprising of garages on the ground floor and a first floor residential apartment at **Mostyn Arms**, **St Georges Road**, **Menai Bridge**.

Some points members wish to make regarding the documents submitted with the above application:

Buildings of historical importance within Menai Bridge.

Conservation Areas

The buildings are located within the Conservation area of Menai Bridge but has not been mentioned in the Anglesey County Council Conservation area Character Appraisal Document – **this is because there never were garages at this location.**

Beneficial

• The building is a very poor state and is a blot on the water front, the renovation of the building will improve the visual impact on this area. An additional dwelling will improve the sense of security in a somewhat vulnerable area of Menai Bridge.

Neutral

Extensions to the first floor will have a neutral impact.

What is this statement referring to?

Proposed development

The proposed development seeks to demolish the current dwelling and replace with one bedroom residential units of high quality.

What is this statement referring to?

From experience of other properties that the developer (Poole Homes) owns in the town, the increase in the number of HMO's and the antisocial behaviour that is increasing is causing grave concerns to residents in the community. There are issues being reported in a property on the same road, managed by the same developer. A more serious incident has occurred recently in another property the developer owns in Menai Bridge.

Flooding has always been an issue in this area whereby the cellar in the Mostyn Arms use to flood. Members, with local knowledge of Menai Bridge reported that the information in the statement accompanying the application are factually incorrect. There has never been garages or a dwelling on the site in question. The submitted location plan is incorrect; this is not how the site looks.

Members have read the response received from the NRW and note its contents therefore urge the Planning Officer/Planning Committee to act accordingly and refuse this application.

Has the planning application for garages on this site been approved? as it states in the applicant's submission. The town council have not received notification of this.

All the above might not be 'planning considerations' but they are extremely important considerations for the Planning Officers and the Planning Committee to consider on behalf of the residents of Menai Bridge.

Action: the Clerk will notify the local planning authority of the Committee's consultation responses.
