Draft Report of the Independent Panel for Wales on the Remuneration of Community and Town Council members

Councils must refund the care costs for dependent children and adults to allow members to undertake their duties. Also, if the report is approved each council will have to pay their members £156 a year (equivalent to £3 a week) towards additional household expenses (including heating, lighting, energy and band wide) obtained from working at home. Members can refuse the payment. From 4 April 2023 this payment is not taxable if there is an arrangement and confirmation from each Councillor that they work from home, and this has been noted. Councillors' costs – £156 per member = $12 \times £156 = £1872$. The above was noted by the members present. Members to notify Clerk of their decision to accept the allowance or not in writing taking the above into consideration.
