- It's been a fairly quiet spell recently apart from the planning applications which the town council's planning committee are aware of.
- It's important for the town council to respond to the 20mph consultation
- The next meeting regarding the bridge is scheduled for November
- Work on the bridge will be completed by August 2025

- Addressed enquiries from the organisers of the Food Festival
- Carried out numerous enquiries regarding VAT registration. SLCC have been very helpful so have Gwynedd Council, the internal auditor
- Assisted the groundsman to tidy up the area near Canolfan Tysilio in preparation for the Food Festival
- I met with Keith Owen the gardener to get an understanding of the gardening work ongoing at the bowling green park and what was there for the groundsman to carry out – productive meeting
- Held various meetings for regular updates with the builder who's refurbishing the shelter in the bowling green park
- While the groundsman was on holiday: cleaned the pavilion and toilet, opened and locked cemetery gate
- Met up with Peter Gardner, regarding the Woodland Management Plan
- Reported graffiti on the toilet building, backing onto the KGV to the IoACC
- Reported various areas with overgrown vegetation to the IoACC
- Contacted Menter Mon regarding benches in the square that have become worn very quickly. They have been restored

- Roedd rhai aelodau yn meddwl ni ddylai y bobl dalu i fynd ar dir cymunedol – os byddai'r cyngor yn caniatáu i'r Wyl fynd yn ei blaen fe fydd cytundeb mewn lle i 'Anglesey Events' gynnal digwyddiad (unwaith y flwyddyn) ac fe fydd y Cyngor yn elwa o £5,000 i ail-fuddsoddi yn y dref
- Mae busnesa y dref yn elwa o'r Wyl ac mae angen cysidro y fflac y cafodd cyngor arall am beidio rhoi caniatáu i'r un math o ddigwyddiad
- Ystyried gostwng y ffi er mwyn i bobl Borth gael mynediad am ddim.
- Adroddodd gwirfoddolwr oedd wedi bod yn helpu allan yn yr Wyl ei bod wedi bod yn ddigwyddiad ffantastig i'r dref

- Adroddodd aelod arall mae £5,000 yn swm enfawr i ail-fuddsoddi yn y dref. Digwyddiad poblogaidd nad oes rhaid i'r cyngor ei drefnu
- Adroddodd y Clerc ei bod wedi derbyn e-bost gan breswlydd y dref i ddiolch i aelodau'r cyngor tref am ganiatáu i'r Wyl Fwyd gael dod i Porthaethwy. Braff oedd, meddai gweld y dref yn brysur a pawb yn mwynhau eu hunain ar y cae cymunedol.

- bod unrhyw sylwadau ar wefannau cymdeithasol mewn ymateb i gwynion am y tâl mynediad yn datgan yn glir mai Anglesey Events Ltd fel busnes er elw sy'n trefnu'r digwyddiad.
- Anglesey Events Ltd sydd yn penderfynnu'r tâl mynediad - ac y bydd unrhyw fath o edliw gan y trefnwyr bod angen codi tâl mynediad oherwydd costau llogi'r cae yn cael ei ystyried fel camwedd ac yn dod a'r cytundeb i ben.

An application from 'Anglesey Events' to hold another Food Festival in Menai Bridge next year was discussed. This is what was discussed:

- Do we want the event to be held on town council land? The festival has been held here three times before with no problems or complaints
- Some members thought that the people should not pay to go on community land - if the council would allow the Festival to go ahead there will be an agreement in place for 'Anglesey Events' to hold an event (once a year) and the Council will benefit from £5,000 to reinvest in the town.
- The businesses of the town benefit from the festival and it is necessary to consider the flak that another council received for not giving permission for the same type of event to go ahead
- Consider reducing the fee so that the people of Menai Bridge can get in for free
- A volunteer who had been helping at the festival reported that it had been a fantastic event for the town
- £5,000 is a large amount of money to re-invest in the town said another member. A popular event that the council don't have to organise
- The Clerk reported that she had received an email from a resident of the town to thank the members of the town council for allowing the Food Festival to come to Menai Bridge. It was nice, she said, to see the town busy and everyone enjoying themselves on the community field.

**It was resolved:**

To give permission for the Food Festival to return to Menai Bridge in 2025 - 5 votes to 4 and 1 abstention

- that the payment of the fee for hiring the land is paid before any equipment is placed on the site
- that any damage to the field, hedges, or buildings on the site is repaired within a reasonable time.
- that there is no obstacle for the public to access the public path through Coed Marquis and that the security fences must be around the field itself.
- that Menai Bridge Town Council's logo is not placed on any marketing material unless that has been agreed in advance - and that marketing advertisements are clear

- that any comments on social media sites in response to complaints about the entry fee state clearly that Anglesey Events Ltd as a for profit business organizes the event and determines the entry fee - and that any form of retaliation by the organizers that it is necessary to raise an entrance fee due to the costs of hiring the field is considered a wrongdoing and the agreement is terminated.
